#### **PHARMACOLOGICAL CLASSIFICATION**

D16.4 Complementary Medicine-Homeopathic,  
Naso-pharyngeal and bucco-pharyngeal antiseptics.

#### **PHARMACOLOGICAL ACTION**

ORASALTS is a Sea Salt based and homoeopathically enhanced Mouth Wash and Gargle. It utilises the natural antibacterial effect of diluted sea salt to target disease oral pathogens while having minimal effect on the normal residual flora of the mouth.

#### **INDICATIONS:**

Indicated as an aid to help relieve puffy bleeding gums, bad breath, gingivitis, periodontitis, viral ulcers, sore throats and any inflammatory condition of the mouth and throat.

#### **CONTRA-INDICATIONS:**

Known hypersensitivity to any of the ingredients.

#### **WARNINGS AND SPECIAL PRECAUTIONS:**

People with Hypertension, Heart Failure or Pulmonary Oedema should only use this product after consultation with their healthcare practitioner.  
Not to be used by children under 5 years old.

#### **PREGNANCY AND LACTATION:**

If you are pregnant or breastfeeding, you should consult your healthcare practitioner before using this product.

#### **DOSAGE & DIRECTIONS FOR USE:**

One level scoop dissolved in 125 ml warm water, twice a day. Rinse and gargle the mouth and throat for 30 seconds and expel liquid. Children half the dosage

#### **INTERACTIONS:**

Drug Interactions – May effect Serum concentrations of lithium.

#### **SIDE EFFECTS:**

Use as a mouth rinse and gargle only. If you have an open wound in and around the mouth/lips area, stinging may occur when used.

Rare adverse reactions that may occur include hypernatremia, tachycardia and hypertension. Not all side effects reported for this medicine are included in this leaflet. Should your general health worsen or if you experience any untoward effects while taking this medicine, please consult your doctor, pharmacist or other health care professional for advice.

If you notice any side effects not mentioned in this leaflet, please inform your doctor or pharmacist.

#### **KNOWN SYMPTOMS OF OVERDOSAGE AND PARTICULARS OF TREATMENT:**

The effects of overdose with sodium chloride solution are not known. In the event of suspected overdosage, consult your doctor or pharmacist. If neither is available, seek help at the nearest hospital or poison control centre. Treatment is symptomatic and supportive.

D16.4 Komplimentêre medikasie-Homeopathic.  
Naso faringeale en bukko faringeale antiseptikums.

### **FARMAKOLOGIESE WERKING**

ORASALTS is 'n seesout basis en homeopaties versterkte Mondwater en Spoelmiddel. Dit maak gebruik van die natuurlike anti-bakteriële uitwerking van opgeloste seesout om kwale en orale siektekieme te teiken terwyl dit 'n minimale impak op die normale flora in die mond maak.

### **INDIKASIE:**

As hulpmiddel vir die verligting van pofferige, bloeiende tandyleis, slegte asem, tandyleisontsteking, periodontitis. Virale ulkusse, seer keel en enige inflammatoriiese kondisie in die mond en keel.

### **KONTRA-INDIKASIES:**

Hipersensitiwiteit vir enige van die bestanddele.

### **WAARSKUWINGS EN SPESIALE**

#### **VOORSORGMAATREËLS:**

Een gelykvol maatlepel opgelos in 125 ml warm water, twee maal per dag. Spoel en gorrel die mond en keel vir 30 sekondes en werp die oplossing uit. Kinders halfeer die dosering.

### **INTERAKSIES:**

Narkotiese Interaksies – Mag serum konsentrasies van lithium afkanteer.

### **NEWE-EFFEKTE:**

Gebruik as mondspoel en gorrelmiddel alleenlik. Indien u 'n oop wond in of om die mond- / liparea het, mag dit prik of steek gedurende gebruik.
